November 7, 2012**

A special meeting of the Town Board was held on Wednesday, November 7, 2012, at 24 Firemen's Way in the Town of LaGrange. Deputy Supervisor Luna called the meeting to order at 6:30 p.m. The Town Clerk led the flag salute.

Mr. Luna asked for a motion to accept the minutes from October 24, 2012. Councilman Jessup so moved, seconded by Councilman Polhemus. The motion carried unanimously.

Public Hearings

Mr. Luna asked for a motion to open the Public Hearing for Benefit Assessments as contained in the completed Assessment Roll for Improvement Districts and Special Districts.

Councilman Jessup so moved, seconded by Councilman Polhemus. The motion carried unanimously.

There were no comments.

Councilman Polhemus moved to close the Public Hearing, seconded by Councilman. The motion carried unanimously.

Councilman moved to accept the completed Assessment Roll for Improvement Districts and Special Districts, seconded by Councilman. The motion carried.

The Public Hearing for Re-Levies for Property Maintenance was held on October 10, 2012. There were no comments from the Public.

Resolution: Town Supervisor to submit statement of re-levy to Dutchess County Real Property Tax for 2013. (SEE ADENDUM)

Mr. Luna asked for a motion to open the Public Hearing for Local Law #6 – Penalties / Code Enforcement.

Councilman Jessup so moved, seconded by Councilman Polhemus. The motion carried unanimously.

There were no comments from the Public.

Mr. Luna stated that the County had returned the Zoning Referral with a notation that the law was of local concern only. The resolution to pass Local Law 6 will be formally adopted at the November 14, 2012 meeting.

Councilman Jessup moved to close the Public Hearing, seconded by Councilman Polhemus. The motion carried unanimously.

Mr. Luna asked for a motion to open the Public Hearing for the 2013 Budget.

Councilman Polhemus so moved, seconded by Councilman Jessup. The motion carried unanimously.

Mr. Luna stated for the record that, library trustee, Bob Kaminsky had called earlier this evening to let him know that no-one from the library would be able to attend tonight's Public Hearing on the 2013 budget. Mr. Kaminsky stated that without a budget increase to \$599,000, the library would not be able to function; adding that a 2% increase from last year is not enough. He noted that the library's rent will be increasing. Mr. Kaminsky further added that library employees have not had a raise in 2 or 3 years; and without a 2% increase in salaries, he feared that the library would not be able to keep the current employees.

Mr. Luna asked for comments from the Board or the Public regarding Mr. Kaminsky's request for an increase to the library budget line.

There were no comments.

Councilman Jessup moved to close the Public Hearing, seconded by Councilman Polhemus. The motion carried unanimously. The 2013 Budget will be voted upon at the next regular meeting, which will be held November 14, 2012.

Councilman Jessup moved to adjourn the meeting, seconded by Councilman Polhemus. The motion carried. The meeting was adjourned at 6:40 pm.
