Attached are the 2007 accomplishments and 2008 plans for the Town of LaGrange Conservation Advisory Council (CAC). We volunteered 198 hours on monthly CAC meetings and approx. 600 hours on a variety of Environmental and Conservation Related Activities in 2007. Highlights of our accomplishments for 2007 are (a) participation at the LaGrange Community Day (b) planting of two CAC demonstration rain gardens in front of town hall (c) response to Mile-a-Minute vine infestation and (d) successful completion of the student environmental display conservation pillars.

More than 200 people visited the CAC exhibit area. It continued to be an excellent venue to hand out environmental information materials and the magnetic fishing game was a big draw for the children. Rain gardens are useful in reducing storm water pollution in addition to being beautiful. The two rain gardens were planted in June and they are the first CAC rain gardens in Dutchess county. Mile-a-Minute vine infestation in LaGrange was an unplanned CAC activity and we responded immediately in working together with Fishkill Creek Watershed Committee and DEC for pulling of the vines. The student environmental conservation pillars were unique and effective in promoting recycling and environmental awareness for earth day 2007.

We (LaGrange CAC) received the 2007 Action Award from the New York State Association of Conservation Commissions and I received the 2007 Margery Sachs Service Award for Lifelong Environmental Concern and Service.

CONSERVATION ADVISORY COUNCIL (CAC) TOWN OF LAGRANGE

2007 ACCOMPLISHMENTS

I. CAC MEMBERSHIP

The town board filled two vacancies in 2007 by promptly appointing qualified and enthusiastic members upon the recommendation the CAC chairman. They are Dr. Paul P. Horstmann, a director at IBM and Ms. Judith Wolf, an active Master Gardener.

II. MONTHLY CAC REVIEWS OF PLANNING BOARD APPLICATIONS

Completed review of almost all of the planning board applications submitted prior to our monthly meetings despite the CAC computer internet connectivity problem (hardware) which occurred in November and December.

III. PUBLIC OUTREACH AND EDUCATION

Continued our active role in the dissemination of educational materials in an outreach effort to inform the community (examples are: Preventing Storm water Pollution, Mile-a-Minute Vine and Blandings's Turtle).

IV. PARTICIPATION AT LAGRANGE COMMUNITY DAY

Operated a CAC exhibit (two tables) and handed out environmental information materials at the LaGrange Community Day on June 9, 2007. Two Earth Day Environmental Conservation pillars made by Overlook Elementary School students were on display. A magnetic fishing game which was introduced two years ago continued to be popular with the children and their families (see appendix C). CAC members Mary Gomez and Linda McPhee planned and organized the event. More than 200 people visited the CAC booth.

V. RAIN GARDEN

Design, site selection, and planting of the CAC demonstration rain gardens was completed as planned. It is the first CAC sponsored rain garden project in Dutchess County. Rain gardens are useful in reducing storm water pollution in addition to being beautiful. The two rain gardens (approx. 110 square feet each) are located in front of the LaGrange town hall on Stringham Road, LaGrange, NY. CAC chair, Maung Htoo learned about rain gardens when he attended a conference by the New York State Association of Conservation Commissions in 2006 and received CAC and town supervisor, Jon Wagner's strong support to implement it. Former CAC member, Dianne Olsen, who writes a weekly column on "Valley Gardener" in the Poughkeepsie Journal, designed the garden and supervised the planting. Several members in the community in addition to CAC members Maung Htoo, Rolf Nijhuis, Nancy Swanson and Mary Gomez participated in the planting on June 3, 2007. (see appendix D). The new plants required many days of watering during the hot and relatively dry summer months. New CAC member, Judy Wolf, who is a Master Gardener, prepared the gardens for the fall and winter. She also started collecting information to put together a brochure for the rain gardens.

VI. MILE-A-MINUTE (MAM) VINE

This was an unplanned activity during the summer of 2007. MAM vine infestation along Jackson Creek near the Ball Field Park in the Town of LaGrange was reported to Department of Environmental Conservation (DEC) by a local resident in June. It covers more than seven acres most of which is privately owned. LaGrange CAC responded rapidly to this problem by working closely with Fishkill Creek Watershed Committee and DEC to pull the vines by the roots in the sparsely infested areas and put them in large plastic bags to be burned at a later date (see Appendix E). Forty four volunteers from many organizations and local citizens spent more than 300 volunteer hours from July 17 to August 19 in this endeavor and pulled more than 210 large trash bags of MAM vine. They were burned by Rick Oestrike, Fishkill Creek Watershed Committee, who co-chaired the effort with Htoo and spent many hours in pulling the vines. CAC members Maung Htoo, Judy Wolf, Rolf Nijhuis, Paul Horstman and Mary Gomez participated. CAC also distributed DEC pamphlets on Mile-A-Minute vine to town highway and recreational dept. employees, had pamphlets available at town hall for the public and made site visits to local citizen's homes to confirm that the vine in their property was not MAM vine. Peter Huff, LaGrange Recreation Director, was very helpful and provided valuable support. The problem received wide publicity in the local newspapers, radio and TV news. This was a significant accomplishment and most of the vines from the sparsely infested areas have been pulled with cost for only the trash bags (donated by Maung Htoo and Rick Oestrike). However, other methods including DEC approved herbicide application would be required to eradicate MAM vines from the heavily infested areas and it is beyond the means of CAC to continue this effort. Maung Htoo submitted a final report to the town supervisor on August 29 in addition to weekly progress reports.

VII. EARTH DAY STUDENT CONSERVATION PILLARS

This unique environmental display project using recycled Sonno tubes was suggested by Mrs. Carol DiPalo, art teacher at the Overlook Elementary School, to CAC member Mary Gomez who co-ordinated the project, purchased the materials and provided transportation. Fourteen classes of grades 1 to 2 students provided the artistic content under the supervision of Mrs. DiPalo and completed 14 conservation pillars for Earth Day, 2007. The project was an outstanding success. The students learned about material conservation, clean air, water and wildlife and expressed themselves in their art work. The Superintendent of Arlington School District, Frank Pepe, was so impressed with the conservation pillars when he first saw them that he wanted two for display at the School District Office. The pillars were also exhibited at area businesses and the LaGrange Community Day in order to create environmental awareness in the community. Four pillars are on display at the LaGrange town hall. (See appendix F).

VIII. WAPPINGER CREEK GREENWAY TRAIL TREE IDENTIFICATION

CAC member, Rolf Nijhuis, has completed purchasing tree signs for the 22 tree species identified in Fall 2006 by Vassar College tree identification class taught by Professor Mark Schlessman.

IX. TRAIL BRIDGE SUPPORT AND STREAM BANK RESTORATION

CAC member, Rolf Nijhuis, discovered severe erosion damage (more than 50 feet) to the supporting banks of the trail bridge due to the floods in April and initiated an action plan for stabilizing both banks and the bridge. This involved contacting DEC Stream Co-ordinator, Jack Isaacs, site visits with the town highway superintendent, Mike Kelly, to work out a technically feasible plan, obtaining the property owner's permission to work on the property and filling out a "non-minor" DEC permit application. CAC member Mary Gomez is helping Rolf with this project.

X. WAPPINGER CREEK WATERSHED INTERMUNICIPAL COUNCIL (WIC)

Maung Htoo attended the WIC Sub-Group meetings on February 21 and March 29, 2007 at the request of town supervisor, Jon Wagner. The purpose of these meetings was to update the WIC By-laws which were initially drafted in 2001. LaGrange councilman, Joe Luna, was also at these meetings.

XI. FISHKILL CREEK WATERSHED COMMITTEE

Maung Htoo worked closely with Rick Oestrike of the Fishkill Watershed Committee as coleaders in MAM vine pulling project this summer.

XII. WAPPINGER CREEK GREENWAY TRAIL EXTENSION

CAC member, Rolf Nijhuis, has been actively involved in this project. Extending the existing trail in the town of LaGrange was not feasible due to objections from one out of three landowners involved. Therefore, feasibility of a new trail in the nearby town owned property is being explored.

XIII. GIS TUTORIAL FOR TOWN BOARD MEMBERS

Rolf Nijhuis gave tutorials on the use of ArcExplorer2 to John Wagner (town supervisor), Alan Bell (planning board chairman), Robert Straub (planning board vice-chairman) and Wanda Livigni, Administrator of Public Works.

XIV. ENVIRONMENTAL AND CONSERVATION RELATED MEETINGS

CAC members attended many useful environmental and conservation related meetings during the year (see appendix B).

XV. CONFERENCE PARTICIPATION

Maung Htoo was an invited speaker at the "2007 Conference on the Environment" sponsored by the New York State Association of Conservation Commissions in Schenectady, NY on October 19-21, 2007. He gave a power point presentation on "Mile-a-Minute Vine Infestation Response Project".

A. AWARDS

- 1. LaGrange CAC received the 2007 Action Award from the New York State Association of Conservation Commissions (NYSACC) for the "Mile-a-Minute Vine Infestation Response Project" at the 2007 Conference on the Environment in Schenectady, NY on October 20, 2007. This award was one of only two action awards presented by NYSACC in 2007. LaGrange CAC is the first CAC in New York state to win action awards for three consecutive years. (2005, 2006 and 2007).



Dr. Maung Htoo Wins The 2007 Margery Sachs Service Award

The twelfth annual Margery Sachs Service Award was presented to Dr. Maung Htoo, Chairman of the Town of LaGrange Conservation Advisory Council and member of the Board of Directors of New York State Association of Conservation Commissions (NYSACC). The award was presented on October 20th at the 2007 New York State Conference on the Environment which was held in Schenectady, NY.


This Award is given in memory of Margery Sachs, one of NYSACC's original directors,
