On Monday May 27, 2019 at 11:00 AM sharp, LaGrange Town Supervisor Alan Bell, along with the LaGrange Town Board, will conduct a Memorial Day Observance at the War Memorial site located at Town Hall 120 Stringham Road.

Boy Scout Troop 3082 and Girl Scout Troop 10587 will conduct a formal salute to our service men and woman who have given so much to ensure our freedom.

LaGrange Town Supervisor Alan Bell "Invites LaGrange residents to attend and take the time to remember the sacrifices made by the members of our military. Pausing each year to thank and remember those who fought for our freedom is our duty."

Assemblyman Kieran Michael Lalor will address attendees. Kieran is a lifelong resident of the Hudson Valley, and a hands-on, innovative and outspoken leader. A former teacher at Our Lady of Lourdes in Poughkeepsie, a Marine Corps veteran of Operation Iraqi Freedom, frequent guest on the Fox News Channel, practicing attorney, and, most importantly, a devoted father of four and husband.

In addition to serving as the Ranking Minority Member of the Assembly Committee on Banks, Lalor also serves as a member of the Assembly Committees on Governmental Operations, Real Property Taxation, Small Business and Veterans' Affairs. Legislatively, Lalor has fought hard to fundamentally reform Albany through initiatives including term limits, recall elections for politicians who violate the public trust, and pension forfeiture for felonious politicians, among many other reforms. Lalor led the call for corrupt former Assembly Speaker Sheldon Silver and Senate Majority Leader Dean Skelos to step down. He opposes irresponsible spending and has voted against every state budget since taking office in 2012 because those record-breaking budgets spent too much and resulted in an increased tax burden on hard working New Yorkers.

Lalor's devotion to others has been evident throughout his life. After graduating from John Jay High School in East Fishkill, Lalor attended Providence College in Rhode Island. After graduation, Lalor was a social studies teacher at Our Lady of Lourdes High School before going into the Marines.

Lalor served as an infantryman in the Marine Corps Reserve. In the aftermath of the September 11, 2001 attacks, his unit was activated twice. Lalor was a Squad Automatic Rifleman while conducting security and stabilization operations in Nasiriyah, Iraq.

When Hurricane Katrina ravaged the Gulf Coast, Lalor and two other Marines were motivated by the way the country rallied behind New York on 9/11 and took it upon themselves to drive 1,400 miles to the impacted area. For his efforts, Lalor was awarded the Navy and Marine Corps Achievement Medal.

After returning from Iraq, Lalor he received his law degree from Pace Law School in White Plains. He is currently a practicing attorney at his own firm in Hopewell Junction.

Lalor is a proud member of many civic and community organizations including the Knights of Columbus, Marine Corps League, Veterans of Foreign Wars, American Legion and Ancient Order of Hibernians. He also coaches local youth football and baseball. Lalor and his wife, Mary Jo, are raising their four children Katie, Riley, Mikey and Kieran, Jr. in Hopewell Junction.
